Taxpayer Advocate Service

The Taxpayer Advocate Service helps taxpayers by taking a “fresh look” at problems that remain unresolved after attempts via normal IRS channels and by assisting taxpayers that have suffered, or will suffer, a significant hardship due to the application of the tax laws. Call a Campus Problem Resolution Office for an issue related to a campus (such as the filing of a return), and call a Local Problem Resolution Office for other issues. Be prepared with your employer identification number, an explanation of the problem and your previous attempts to solve it, and the contact information for the prior IRS office you approached.
